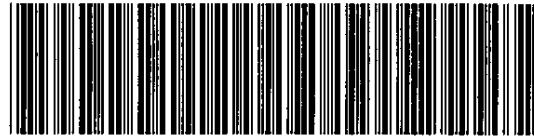



Article VIII – Amendment


