**ARTICLES OF DISSOLUTION  
OF

**a Florida corporation**

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, **EMOTRON LATIN AMERICA, INC.**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is **EMOTRON LATIN AMERICA, INC.**
2. The filing date of the Articles of Incorporation of the Corporation was February 14, 2006, under Document No. P06000022002.
3. The dissolution was authorized and approved by the sole Shareholder and all of the Directors of the Corporation by Written Consent dated February 28, 2014, which is sufficient approval and authorization for the dissolution of the Corporation.
4. The officers or representatives of the Corporation have paid and discharged all of the Corporation's debts, obligations and liabilities or have made adequate provisions for all debts, obligations and liabilities of the Corporation, including the distribution of all remaining property and assets, if any, to the sole Shareholder of the Corporation in accordance with their respective rights and interests.
5. There are no suits pending against the Corporation in any court.

In accordance with Section 607.1403 of the Florida Business Corporation Act, the dissolution of the Corporation shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
