ARTICLES OF INCORPORATION

INDUSTRIOUS DESIGN, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is INDUSTRIOUS DESIGN, INC.

ARTICLE II - ADDRESS

The principal place of business and mailing address of the Corporation is:

ARTICLE III - DURATION

This corporation shall have perpetual existence

ARTICLE IV- PURPOSE

The purpose for which the corporation is organized is to engage in and operate a business for the purpose of developing, manufacturing and selling products that enhance engine performance and other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be a single class of common stock of a par value of \$3,500.00.

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro-rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE X - EXAMINATION OF CORPORATE RECORDS

Any director of the corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he also is a director of such subsidiary or controlled company.

ARTICLE XII - INDEMNIFICATION

The corporation shall indemnify any Officer or Director or any former Officer or Director, to the full extent permitted by law.

ARTICLE XIII - AMENDMENT
