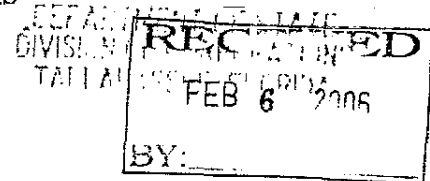

THE UNDERSIGNED, acting as sole incorporator of JEARRI JOAN BUSH, P.A., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

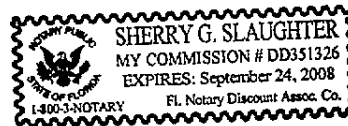
