ARTICLE I.

The name of this corporation is LSK MOBILE HOMES, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is $13915\ 83^{rd}$ Place North, Seminole, FL 33776.

ARTICLE III. DURATION; EFFECTIVE DATE
