CERTIFICATE OF INCORPORATION

OINSECRETATION OF THE O

DRY RITE RESTORATIONS INC.

We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of an Act of the Legislature of the State of Florida approved June 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

FIRST: The name of the Corporation is:

DRY RITE RESTORATIONS INC.

SECOND: The general nature of business to be transacted by the Corporation is as follows: To operate as a carpet cleaning and carpet restoration business. To acquire by purchase, or otherwise, and to own, hold, sell, Real Estate in the State of Florida and the United States at large. To manufacture, purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise and other personal and real property of every class and description whatsoever.

To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitably

dealt with in connection with any of the said business.
