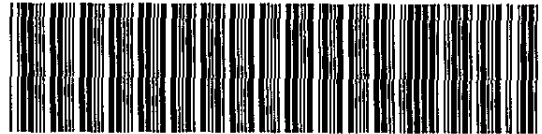



**ARTICLE ONE**

**The name of the corporation is NOTORIOUS ENTERPRISES, INC.**

**ARTICLE TWO**

**The period of its duration is perpetual. The effective date for the corporation shall be February 8, 2006.**






