

ARTICLES OF INCORPORATION OF SRMBF Enterprises, Inc.



The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is SRMBF Enterprises, Inc.

ARTICLE II - Principal Office and Mailing Address

The street address of the principal office is: 19735 Prince Benjamin Drive, Lutz, Florida 33549 and the mailing address of the principal office is 16307 Newberry Palms Court, Tampa, Florida 33647.

ARTICLE III - Shares

The number of shares the corporation is authorized to issue is One Hundred (100) shares. The par value is \$1.00 per share. Each share of stock shall be entitled to one (1) vote, and in the election of directors of the corporation, the holders of the stock shall be entitled to vote their stock cumulatively.

This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms, and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
