Articles of Incorporation of Innovative Office, Corp.

We the undersigned do hereby subscribe these Articles of Incorporation for the purpose of forming a corporation under laws of the State of Florida, Chapter 607, and subject to the following provisions.

Article One

The name of the corporation shall be: Innovative Office, Corp.

Article Two

The corporation shall be perpetual existence and may engage in any activity or business permitted under the laws of the United States and the State of Florida; more specifically: to operate a virtual office.

The corporation shall issue 1,000,000 (one million) shares of common stock have a .10 per value.
