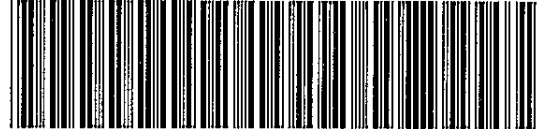

ARTICLES OF INCORPORATION

OF

THE SWEAT SHOP *Body + Paint, INC*

THE UNDERSIGNED, acting as incorporator of THE SWEAT SHOP, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I
