ARTICLES OF INCORPORATION OF R&W Foods, Inc.

In compliance will the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is R&W Foods, Inc.. The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.
