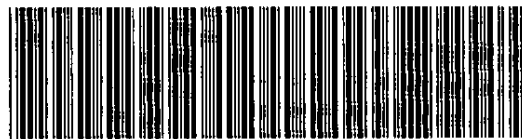

This is to advise you that the corporation named Doughmonde, Inc (Doc#: P06000023848) closed the business back in 2008.


Due to the tumultuous circumstances at the time of business closing, the corporation did not file the articles of dissolution with the State of Florida appropriately.
