I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I Name and Principal Address

The name and principal address of the corporation shall be: Sun Belt Martial Arts Center, Inc., 10550-8 Old St. Augustine Road, Jacksonville, Florida 32257. The mailing address is the same.

ARTICLE II Duration

This corporation shall have perpetual existence.

ARTICLE III Purpose
