ARTICLE L - CORPORATE NAME

The name of the Corporation is TAYSTEE GOURMET BAKERY 2, INC.

ARTICLE II. - CORPORATE DURATION

The duration of the Corporation is perpetual, and the Corporate existence is to commence upon the execution hereof.

ARTICLE III. - PURPOSE AND POWERS
