ARTICLES OF INCORPORATION

ARTICLE I <u>NAME</u>

The name of this Corporation **EL BODEGON DEL VINO, CORP.** and its mailing address 8737 Coral Way, Miami, Florida 33165.

ARTICLE II NATURE OF BUSINESS
