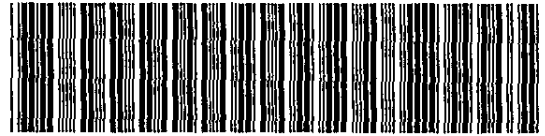

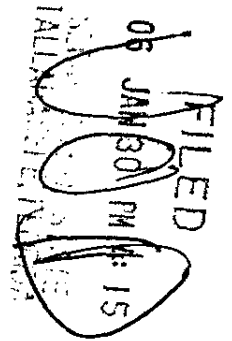



**ARTICLE I. CORPORATE NAME.**

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS.**

**ARTICLE III. PURPOSE.**

The Corporation shall indemnify any officer or Director, or any former officer, to the full extent permitted by law.

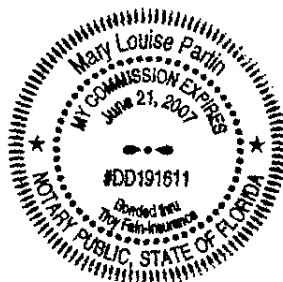


