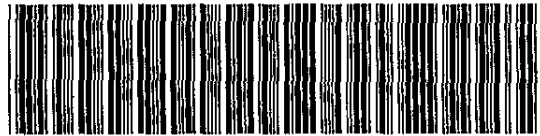



The undersigned, acting as incorporator of Redfoot Furniture, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.
