The undersigned subscriber to these Articles, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida and under the following Articles:

**ARTICLE I: NAME**

The name of the corporation shall be ROBERT L. FOWLER REMODELING & RENOVATION, INC.

**ARTICLE II: PRINCIPAL OF BUSINESS**

The principal place of business and the mailing address of the corporation shall be 270 Coyote Road, Defuniak Spring, Fl. 32433.

**ARTICLE III: PURPOSE OF CORPORATION**

This corporation shall conduct business in remodeling, repairing, and renovations of residential and business locations. The corporation shall not conduct any business regarding banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, or a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, or a State Fair or Exposition. Subject to such limitations, it shall engage in a for-profit activity or business as permitted under the laws of the State of Florida and the United States.

**ARTICLE IV: SHARES OF STOCK**

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 1000 shares of Common Stock having a nominal par value of \$1.00 per share.

**ARTICLE V: DIRECTORS/OFFICERS**


