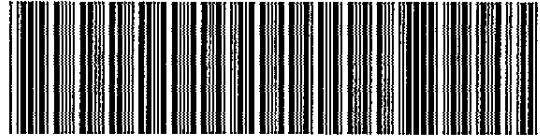

**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I - Name**

The name of this Corporation is **ENDEAVOR FINANCIAL GROUP, INC.** The principal place of business of this Corporation shall be 2217 Shadehill Ct., Tampa, FL 33612 or such other place as may be designated by the Board of Directors.

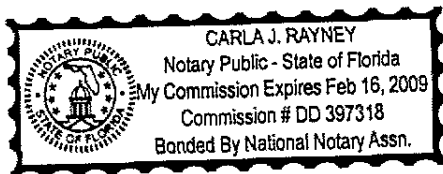
