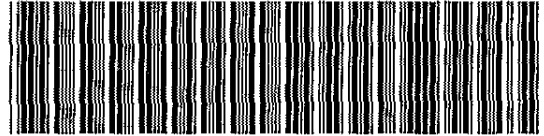

### **Initial Board of Directors**



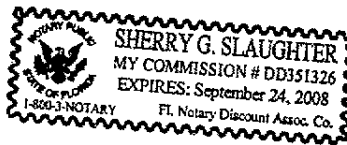
