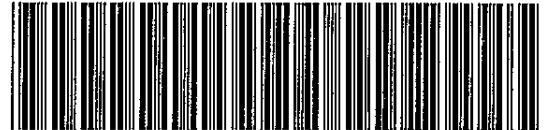



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is ADVANCED BUILDERS COLLEGE, INC.

ARTICLE II.

The main location where the company shall conduct its business is 6640 103rd Street, Suite B, Jacksonville, Florida 32210.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.



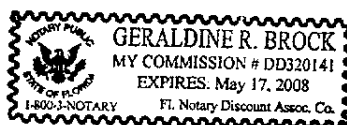
