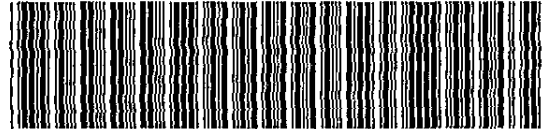

On 2/20/2006, I filed the Articles of Incorporation for a new Corporation. An accountant, Stella Ehne, prepared the paperwork and filed it for me.

Unfortunately, I never received a time-stamped copy of the Articles of Incorporation from the State.

When I called the State Division of Corporations, I was told that they were mailed out to Ms. Stella. She did not give me a time-stamped copy of the Articles.


Therefore, I cannot be assured that the Corporation exists; and am forced to believe that there is the possibility of fraud by my accountant (who, at our last meeting, told me to "take my business elsewhere").

Therefore I am forced to dissolve the Corporation. No shares have been issued by the Corporation, and I am the President and CEO. There have been no Meetings or Minutes or Laws/Bye-Laws adopted; because without acknowledgement from the Department of State I do not know if the Corporation exists at all. There has been no business commenced by the Corporation.

Enclosed please find the forms required to dissolve the corporation, along with a Check for the fee required (\$52 for Filing Fee, Certified Copy & Certificate of Status)

In the future, perhaps your office would avoid such inconveniences to customers by ensuring that a copy of the articles of incorporation is mailed out to an Officer of the Corporation and not a third party.
