

The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, hereby form a professional association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

Jana L. Jones, P.A.

The principal place of business of this corporation shall be, 11325 N. Oakleaf Ave., Tampa, FL 33612.

ARTICLE II. NATURE OF BUSINESS

The purpose of this corporation is to engage in every aspect of the business of rendering the same professional services to the public that a Realtor, duly licensed under the laws of the State of Florida, is authorized to render.
