ARTICLES OF INCORPORATION

TO PERSONAL SERVICE SE HENRY GARCIA COMPANY / FIREMASTER FRANCHISEE

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is HENRY GARCIA COMPANY / FIREMASTER FRANCHISEE.

ARTICLE II - NATURE OF BUSINESS
