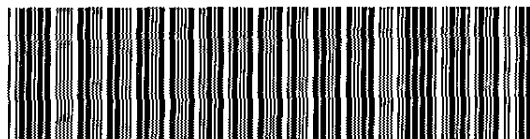

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract,  
hereby form a corporation under the laws of the state of Florida.

**ARTICLE I- NAME**

The name of this corporation is J SANCHEZ CONSTRUCTION, INC.

**ARTICLE II- DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with  
the Department of State.

**ARTICLE III- PURPOSE**

This corporation is organized for the purpose of transacting any and lawful business for which corporations  
may be incorporated under the Florida General Corporation Act.

**ARTICLE IV- CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock which  
shall be designated as "Common Shares."




