THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HRQ, INC., a Florida corporation (the "Company"), are executed by the undersigned President of the Company for the purposes set forth herein:

1. The name of the corporation is HRQ, Inc.
2. The Articles of Incorporation were filed on February 21, 2006 and assigned document number P06000026609.
