ARTICLES OF INCORPORATION 06 FEB 21 PM 2: 32 OF TALLAMASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: EDEN ROAD, INC. The principal office of the Corporation is 244 Sunset Court, Davenport, Florida 33837. The mailing address of the Corporation is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.
 - Article 2. Duration. The duration of the Corporation is perpetual.
