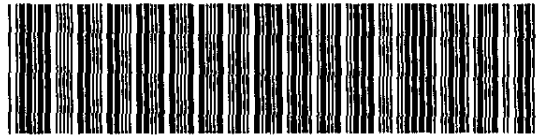

ARTICLE I - NAME

The name of this corporation is JF OF NE FLORIDA INC.

ARTICLE II - DURATION


