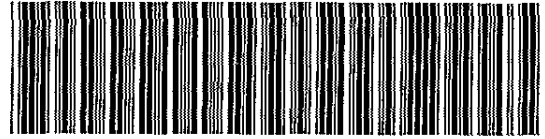

ARTICLE VI






