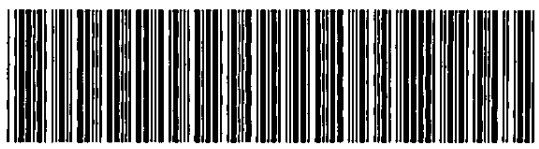

AMENDED ARTICLES OF INCORPORATION

OF

TOP GUN RENOVATIONS, INC.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned as directors of the corporation adopt and file the following amended articles of incorporation to more clearly define the powers and purposes of the corporation and to correct typographical errors contained in the Electronic Articles of Incorporation heretofore filed as set out hereinafter:

ARTICLE I

The name of the Corporation ("Corporation") is TOP GUN RENOVATIONS, INC.

ARTICLE II

The existence of the Corporation began on February 23, 2006, upon the filing of the Electronic Articles of Incorporation which this instrument amends.

ARTICLE III

The street address of the principal office of the Corporation is 1755 Briza del Mar Drive, Navarre, Florida 32566.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ONE HUNDRED (100) with a par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each

ARTICLE V

ARTICLE VI


ARTICLE VIII


