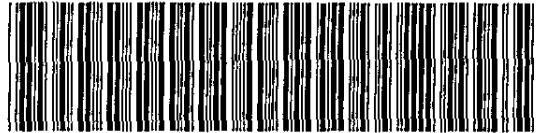

The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is Kwik Money Remittance Florida, Inc.

ARTICLE 2. DURATION. The duration of the corporation is perpetual.

ARTICLE 5. INITIAL OFFICERS AND DIRECTORS. The initial officers and directors of the corporation shall be:

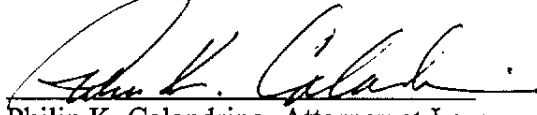

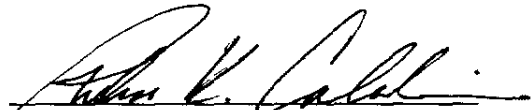
