OF

The undersigned, desiring to form a for profit corporation under the Corporation Law of Florida, Chapter 607 of the Florida Statutes, hereby certifies:

ARTICLE I – NAME

The name of the Corporation shall be IN GOD EVERY THING POSSIBLE, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal office of the Corporation is located at 2517 N. Dixie Highway, Lake Worth, Florida Palm Beach County.

ARTICLE III – PURPOSE
