

## ARTICLES OF INCORPORATION OF SUNRAY LANDSCAPING, INC.

The undersigned, desiring to form a corporation under the provisions of Sections 607 et seq., Florida Business Corporation Act, as amended, hereby sets forth the following:

- Article I. Name & Address. The name and principal office address of this Corporation is SUNRAY LANDSCAPING, INC., 11125 Park Blvd, Suite 104-101, Seminole, FL 33772.
- Article II. Mailing Address. The Corporation's -mailing address is SUNRAY LANDSCAPING, INC., 11125 Park Blvd, Suite 104-101, Seminole, FL 33772.
- Article III. <u>Duration</u>. This Corporation shall exist perpetually, commencing as of the date of execution of these Articles.
- Article IV. <u>Purpose</u>. This Corporation is organized for the purpose of transacting any and all lawful business.
- Article V. Stock. This Corporation is authorized to issue 1,000,000 shares of ONE DOLLAR (\$1.00) par value common stock.
- Article VI. Officers. The initial Officer of this Corporation is TODD M. CRALLEY, 11125 Park Blvd, Suite 104-101, Seminole, FL 33772
- Article VII. <u>Directors</u>. The initial Board of Directors of this Corporation shall consist of two members. The number of directors may be either increased or decreased from time to time by the Bylaws but shall never be less than one member. The names and addresses of the initial directors of this Corporation are TODD M. CRALLEY, 11125 Park Blvd, Suite 104-101, Seminole, FL 33772 and JACQUELINE K. CRALLEY, 11125 Park Blvd, Suite 104-101, Seminole, FL 33772.
- Article VIII. Registered Agent. The name of the initial registered agent and the street address of the initial registered office of this Corporation is RICK W. SADORF, ESQ., Lefter, Wilkinson & Sadorf, LLC, 2201 NE Coachman Road, #102, Clearwater, FL 33765
- Article IX. <u>Incorporator</u>. The name and address of the person signing these Articles as Incorporator is RICK W. SADORF, ESQ., Lefter, Wilkinson & Sadorf, LLC, 2201 NE Coachman Road, #102, Clearwater, FL 33765.
- Article X. <u>Pre-Emptive Right.</u> Each holder of the common stock of this Corporation shall have the first right (subject to adjustments to avoid the issuance of fractional shares) to purchase shares of any other securities that this Corporation may issue from time to time, whether or

not such shares are presently authorized, including shares from the treasury of this Corporation, in the ratio that the number of shares of common stock held by such shareholder at the time of the issue bears to the total number of shares of common stock then outstanding. This right is waived by any holder of the common stock who does not exercise it and pay for the stock available for purchase pursuant to such preemptive rights, within thirty (30) days of his receipt of a written notice from this Corporation inviting him to exercise such right.

Article XI. <u>Indomnification</u>. The Corporation shall indomnify any officer or director, or any former officer or director, to the full extent permitted by law.

Article XII. Bylaws. The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amond or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

Article XIII. <u>Amendments</u>. This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
