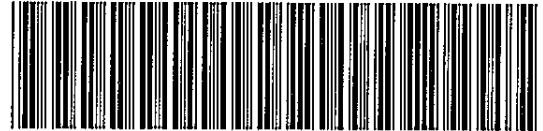

The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.


Article VII – Registered Agent

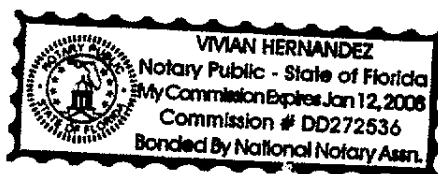
