**ARTICLES OF INCORPORATION
OF
JOANNA DROWOS DO, MPH, P.A.**

The undersigned, being a natural person, competent to contract and licensed to practice law in the State of Florida, acting hereby as incorporator for the purpose of establishing a Professional Service corporation under the provisions and subject to the requirements of the laws of the State of Florida, particularly Chapters 607, Florida Business Corporation Act, and Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the corporation (hereinafter called the "Corporation") is:
JOANNA DROWOS DO, MPH, P.A.
- SECOND:** The principal address and mailing address is as follows: 295 NE 5th Avenue, # 29, Delray Beach, FL 33483
- THIRD:** The Corporation is organized for the purpose of engaging in (i) the practice of clinical medicine, (ii) public educational speaking, (iii) medical and public health consulting and (iv) any other medical services permitted under Florida law. The Corporation shall engage and render the professional services involved only through its officers, agents and employees who shall be legally authorized within the State of Florida to render the same professional service as this Corporation.
- FOURTH:** The Corporation is authorized to issue ONE THOUSAND (1,000) shares of common stock, par value \$0.10 per share. Shares of the Corporation's stock and certificates shall be issued only to individuals in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.
- FIFTH:** The Corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapters 607 and 621, Florida Statutes, as amended and supplemented.
- SIXTH:** The Corporation is to have perpetual existence unless dissolved according to law.
- SEVENTH:** The Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time as provided in the By-Laws but shall never be less than one.
