CORPORATE NAME



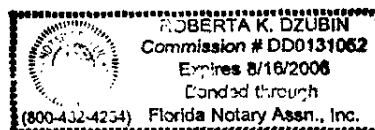


