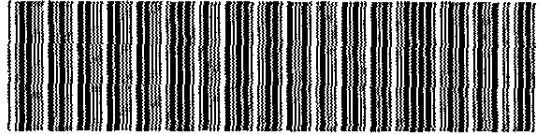


Due to serious health reasons the above mentioned business will no longer exist and has gone out of business. I was not sure of how to notify your office and I hope this is appropriate.
