ARTICLES OF INCORPORATION OF A TIME TO CHANGE COUNSELING CENTER, P.A.

The undersigned subscribers to these articles of incorporation, being dilly Richisco HOFLORIDA practice counseling under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE 1. NAME

The name of the professional service corporation is A Time To Change Counseling Center, P.A.

ARTICLE II. PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of counseling. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary or desirable for the rendering of professional services.

ARTICLE III. TERM OF EXISTENCE

The professional service corporation shall have perpetual existence.

ARTICLE IV. CAPITAL STOCK

ARTICLE VII. RESTRAINT ON ALIENATION OF SHARES

The shareholders of the professional service corporation shall have the power to include in the bylaws, adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions and details, of the disposition shall be determined by the shareholders of the professional service corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder of the professional service corporation may sell or transfer his/her stock in the corporation except to another individual who is eligible to be a shareholder of the professional service corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice counseling in the State of Florida or is elected to a public office or accepts employment that places restrictions or limitations on his/her continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

ARTICLE VIII. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.

ARTICLE IX. REGISTERED OFFICE AND AGENT

The address of the initial registered office of this professional service corporation is 3232 Crawfordville Highway, Crawfordville, Florida 32327. The name of the initial registered agent at that address is Cyndi Goodwin. The principal office is the same.
