ARTICLES OF INCORPORATION

OF

4M VENTURES, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is 4M VENTURES, INC.




