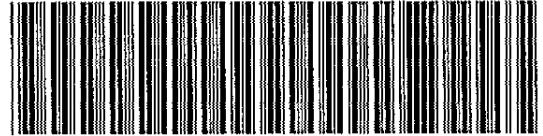

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Dancing Dragon Health & Wellness, Inc. Its principal office address and business mailing address is: c/o Heidi A. Roche, 2600 Greenwood Terrace, #105, Boca Raton, Fl 33431.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**
