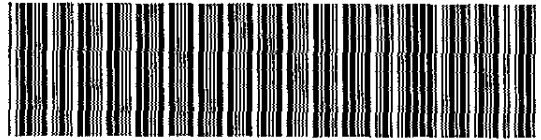

Provisions for regulating the internal affairs of the corporation are that shareholders will regulate the internal affairs of the corporation.

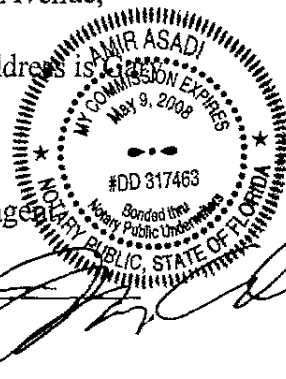


