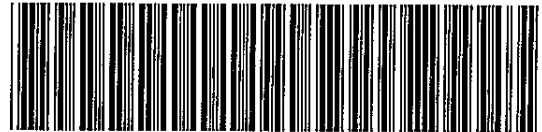

ARTICLE I- NAME

The name of this corporation is **INVENTION INVESTORS , INC.**

ARTICLE II – DURATION


ARTICLE X – INDEMNIFICATION


