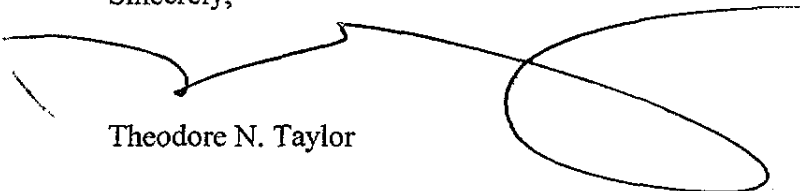

**ARTICLE ONE - NAME**

The name of this Corporation shall be **SEFFNER EARLY DEVELOPMENT CENTER, INC.**, with its principal place of business located at **11825 East Highway 92, Seffner, Florida 33584.**

**ARTICLE TWO - DURATION**

The Corporation shall have a perpetual existence, commencing on the date of filing.

**ARTICLE THREE - PURPOSE**

The Corporation is organized to provide child care and preschool preparation services, and to engage in any other activity or business permitted under the laws of the United States and the State of Florida, necessary to carry out the purposes herein.

**ARTICLE FOUR - CAPITAL STOCK**

The Corporation is authorized to issue five hundred (500) shares of common stock having a par value of one dollar (\$1.00) per share.

**ARTICLE FIVE - INITIAL REGISTERED OFFICE AND AGENT**
