

The undersigned incorporator hereby makes, subscribes to, acknowledges, and files these Articles of Incorporation for the purpose of organizing and incorporating a Corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is, and shall be "C&M ENTERPRISES OF VOLUSIA COUNTY, INC.," and it shall be hereinafter referred to as the "Corporation". The principal place of business and mailing address of the Corporation is 10 Cottonwood Flat, Ormond Beach, Florida 32174.

ARTICLE II

The time and date on which corporate existence of this Corporation shall begin is upon the filing of these Articles of Incorporation, and this Corporation shall have continuous and perpetual existence thereafter.

ARTICLE III

The general purpose for which the Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares. These shares shall consist of one class only, and that class shall be known as "common shares" of the Corporation. These shares shall have a par value of \$1.00 per share.


