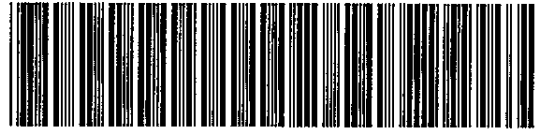

ARTICLE I
NAME

The name of this corporation is:

DURATION

This corporation shall have perpetual existence.

5. The rights, if any, of the shareholders of shares of each series to convert such shares into common shares and the terms and conditions of such conversion.

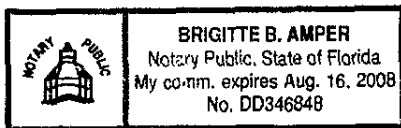
