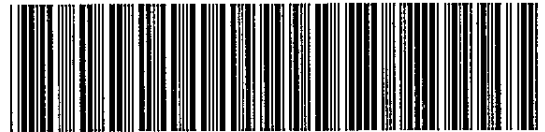



The name of this corporation shall be PAEC, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III
