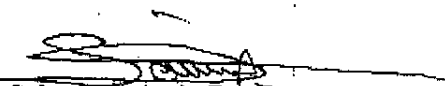

### ARTICLE I Name of Corporation

The name of this corporation is S & L GLOBAL TRANSPORT INC.

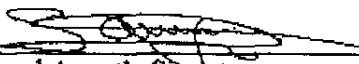

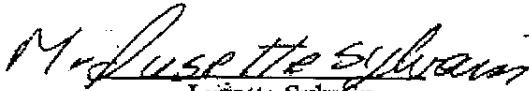
