## ARTICLE I Name of Corporation

The name of this corporation is S & L GLOBAL TRANSPORT INC.

## ARTICLE II Purpose

Organized primarily as a supplier of transportation services, S & L GLOBAL TRANSPORT INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

### ARTICLE III Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.
