I, THE UNDERSIGNED, hereby come forth for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

### ARTICLE I

The name of the corporation shall be: LA SUBGRA TABBRNA CORP. It's business shall be carried on in the State of Florids, in the United States of America, and elsewhere, as may be authorized by the Board of Directors.
