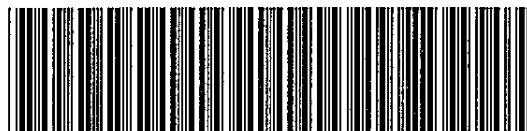

The undersigned, acting as incorporator of PORE BABY MEDSPA, P.A. under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is PORE BABY MEDSPA, P.A.

ARTICLE II. ADDRESS

The mailing address of the corporation is 790 Estuary Way, Delray Beach, Florida 33483.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon the filing of these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in skin care and medical spa activities or businesses – as permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of class A voting common stock, and 1,000 shares of class B nonvoting common stock, having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1325 Diplomat Parkway, Hollywood, Florida 33019, and the name of the corporation's initial registered agent at that address is Kenneth D. Kossow.

ARTICLE VII. INCORPORATOR

The name and street address of the incorporator are Kenneth D. Kossow, 1325 Diplomat Parkway, Hollywood, Florida 33019.

The incorporator of the corporation assigns to this corporation his rights under Section 607.0201, Florida Statutes, to constitute a corporation, and he assigns to those persons designated by the board of directors any rights he may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.

ARTICLE VIII. BYLAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

ARTICLE IX. AMENDMENTS

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.


